ORDER AND DECREE AMENDING  
DESCRIPTION OF DISTRICT

THIS MATTER COMING ON TO BE HEARD This 7th day of  
July, 1952, on the Motion of the District to amend the description  
of the above entitled District, and the Court being fully advised;

ORDERS AND DECREES That the Order and Decree heretofore  
entered on the 10th day of April, 1952, be and the same is hereby  
amended to describe said District, as follows:

Commencing at the center of the intersection of  
South Holly Street and East Yale Avenue; thence south  
on a line parallel with South Holly Street 1980 feet;  
thence east on a line parallel with East Yale Avenue  
to the north and south center line of the Northwest  
Quarter of Section 32; thence north along the north  
and south center line of the Northwest Quarter of said  
Section 32 and the north and south center line of the  
Southwest Quarter of Section 29 to the south boundary  
line of the High Line Canal; thence northwesterly along  
the south boundary of said High Line Canal to the north  
boundary of Plot 39 of University Addition; thence west  
along the north line of said Plot 39 to the east line  
of South Holly Street; thence south along the east line  
of South Holly Street to the south boundary of Dickin-  
son Place; thence west along the south boundary of  
Dickinson Place to the east boundary of the Valley High-  
way; thence in a southeasterly direction along the north-  
erly line of the Valley Highway to a point which is 929.8  
feet west of the northeast corner of Section 31; thence  
east 929.8 feet to the point of beginning, all in Town-  
ship 4 South, Range 67 West, in Arapahoe County, State  
of Colorado.

This matter coming on to be heard in open Court, and it appearing that Notice of the Election, held on the 5th day of April, A. D. 1952, at which there was submitted the matter of the organization of Holly Hills Water and Sanitation District, Arapahoe County, Colorado, and the election of Directors for such District, was duly published in compliance with the Order of Court entered the 10th day of March, A. D. 1952, and in accordance with the requirements of law.

And it further appearing that said election was duly held at the time and place and by the Judges of election appointed by the Court; that at said election 8 ballots were cast for the organization of the District and no ballots were cast against the organization of the District; that Abbie L. Stroup, George Baily, Harold O. McCurdy, V. J. Dunton and H. B. Stroup were duly elected as Directors of said District, and the Court being fully advised in the premises, hereby ORDERS AND DECREES THAT:

Said District has been duly and regularly organized pursuant to Chapter 175, Session Laws of Colorado, 1939, as amended and as re-enacted and amended by Chapter 253, Session Laws of Colorado, 1949, and shall be known as "Holly Hills Water and Sanitation District," in Arapahoe County, Colorado;

Said District is within the following described boundaries:

Commencing at the center of the intersection of South Holly Street and East Yale Avenue; thence south on a line parallel with South Holly Street 1980 feet; thence east on a line parallel with East Yale Avenue to the north and south center line of the Northwest Quarter of Section 32; thence north along the north and south center line of the Northwest Quarter of said Section 32 and the north and south center line of the Southwest Quarter of Section 29 to the south boundary line of the High Line Canal; thence northwesterly along the south boundary of said High Line Canal to the ~~(west)~~ <sup>North</sup> boundary of Plot 39 of University Addition; thence south along the east line of South Holly Street to the south boundary of Dickinson Place; thence west along the south boundary of Dickinson Place to the east boundary of the Valley Highway; thence in a southeasterly direction along the northerly line of the Valley Highway to a point which is 929.8 feet west of the northeast corner of Section 31; thence east 929.8 feet to the point of beginning, all in Township 4 South, Range 67 West, in Arapahoe County, State of Colorado.

That the first Board of Directors of said District shall consist of Abbie L. Stroup, to act until the first biennial election; George Baily and Harold O. McCurdy, to act until the second biennial election, and V. J. Dunton and H. B. Stroup, to act until the third biennial election; that said District shall be a governmental subdivision of the State of Colorado, and a body corporate with all the powers of a public or quasi municipal corporation; that said Board of Directors shall take such steps and proceedings as the needs of the District require and that within thirty (30) days after the date hereof the Clerk of this Court shall transmit to the County Clerk and Recorder of Arapahoe County, Colorado, a certified copy of this Order and Decree for filing in his office.
